The committee is typically composed of representatives from accounting standard setting bodies or institutes, major accounting firms, government bodies (where applicable), and academics. The translations are reviewed carefully to ensure that the English and the translation both give the same message. If we are informed of any issues regarding a translation, we ask the review committee to consider them, and if necessary, revise the translation.
